**b. Education Workshops**

**d. Tecumseh Corn Festival**

Further to the suggestion at the last meeting, arrangements have been made for the Committee to have a booth at the Tecumseh Corn Festival on Seniors Day, Friday, August 23. The Members are asked to mark their calendars to oversee the booth.

The Members will brainstorm questions for a brief survey to engage seniors on what education topics, as well as other senior initiatives that are of interest. A suggestion is made to have prize incentives to encourage older adults and seniors to partake in the survey.

**8. New Business**

**a. Seniors Community Grant Program**

The Manager Committee & Community Services advises the Ministry for Seniors and Accessibility has just released the 2019-2020 Seniors Community Grant Program (Program).

The Program is solely dedicated to helping seniors, which will encourage greater social inclusion, learning, volunteerism, and community engagement. Funding, under the Program, will support projects which meet at least one of the four (4) key priorities outlined in the Program Guidelines.

The submission deadline to make application is June 27, 2019. All projects must be completed by March 31, 2020.

Discussion ensues regarding examples of eligible projects that may align with the Committee’s priorities. The Manager Committee & Community Services shares ideas from day trips the Town of Essex organized under the same Program.

The Committee concurs with making application for ‘Lunch ‘n Learns’ whereby various topics such as art therapy, senior safety, Powers of Attorney and Inheritance Tax, exercise activities, and the like could be offered to Tecumseh older adults and seniors. Lunch would be provided and participants could receive a related giveaway with each workshop. The Members will forward any further topic suggestions to the Manager Committee & Community Services by the end of next week.

**b. SAC Article**

A suggestion is made to draft an article for the local newspapers to educate older adults and seniors on what the Committee does and the various initiatives.
